St Lucie County Fairgrounds: 5202 Peacock Rd., Fort Pierce, FL 34945

<u>From West:</u> Take State Road 70 east (Okeechobee Rd), turn right onto Peacock Rd. If you pass under the pedestrian overpass, you have gone too far. Turn left into SLC Fairgrounds rear entrance.

<u>From I-95:</u> Take exit #129, State Road 70 (Okeechobee Rd), go west 6.5 miles. Turn left on Peacock Rd. just past the pedestrian overpass. Turn left into SLC Fairgrounds rear entrance.

<u>From FL Turnpike</u>: Take Exit #152, State Road 70 (Okeechobee Rd), go west 6 miles. Turn left on Peacock Rd. just past the pedestrian overpass. Turn left into SLC Fairgrounds rear entrance.

BITCHES IN SEASON MAY PARTICIPATE

Bitches in season (BIS) may compete at Barn Hunt trials. BIS will be run at the end of each class. BIS must always wear pants/britches when not being pottied including on the course. Owners of BIS should crate/confine their dogs away from traffic and other dogs, should post "dog in season" signs on their crate/in their area, and potty the dog away from other competitors. Owners of BIS should make their condition known to the Trial Secretary prior to arrival, if possible, and no later than 15 minutes before the start of the first trial. Entry fees (minus recording fees) will be refunded if BIS is withdrawn from the trial.

AWARDS

Placement ribbons will be awarded for $1^{st} - 4^{th}$ place in all regular classes (not Instinct) in each height division. Brown qualifying ribbons will be awarded for all qualifiers in the regular classes. New Title Ribbons will be awarded to those who quality for them and for dogs first pass in the Instinct Test. High in Class Rosettes or Medals will also be awarded in each class.

NOTICE TO EXHIBITORS

*Registration number and Barn Hunt Regulations may be obtained on the website www.barnhunt. com

* **Refunds:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fees will be refunded If the trial cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee. **Refunds will not be given for** withdraws after the closing date!

* Bring a chair for yourself and crates for your dog(s).

* Please make sure your crate is secure as the dogs may be overly excited. If your dog is overly excited, please do not leave him/her unattended if they bark.

* Any dog of any breed or mix, six months of age or older, may participate in Barn Hunt Trials.

* Dogs must be able to fit through an 18" wide by approximately 22" high "tunnel" made of straw/hay bales.

* Height Divisions: Small, Dogs 15" & under; Medium, Dogs 15.1" to 22"; Large, Dogs over 22". Dogs are measured at the option of the judge.

* Possessing or training with personal, live quarry is not permitted on the show grounds at any time.

* All dogs must be on leash at all times except when in the ring for judging. Please be mindful of other exhibitors and keep your dog close to you. We may ask you to cover your dog's crate or remove them from the crating area if they're excessively loud.

* Exhibitors are responsible for being ready to go in blinds and for not holding up a class. The club has no obligation or responsibility to search for or locate a dog not brought to the ring when required.

* Owners are responsible for errors made on entry forms, whoever may have made such errors.

* T a i I w a g g e r s a n d Members assume no responsibility for any loss, damage, or Injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, vehicles or children.

* Exhibitors are responsible for cleaning up after their dogs! Do not let your dogs pee on *anything man-made*. It is grounds for immediate dismissal and possible suspension from BHA if you do!

- The blind will be loaded with 4 or 5 competitors
- Mask are optional!
- Dogs may enter the Instinct and Novice class in the same trial until the dog has earned the RATN title.

ENTRY FEE AND DEADLINES

Entries will be accepted in order received. Your entry must be complete with BHA number and signed with liability waiver initialed or they will not be accepted. Entries made without fees, barn hunt number or signature will not be accepted and are filed away as an invalid entry. No notification will be sent out regarding invalid entry.
