

# Ocala 2023 Fall Circuit RV Parking Reservation Information

The Ocala Fall Circuit will be located at the Greater Ocala Dog Club Show Grounds, just two and a half miles off of I-75 in Ocala. Florida.

Our sites are approximately 30 foot by 50 foot and includes electric. If your unit is longer than 50 feet you will need to either purchase two sites or find a friend that has a smaller unit and is willing to share their spot. You must send these in together and explain you need an end to end spot so you can share. Additional overnight RV parking is available without Electricity for \$20.00 per night. If you need to drop your trailer after you unload to a different area so you fit, we will provide you one at no additional charge. If your tow car doesn't fit into your space please move it to day parking. If you tow a car onto the show grounds you will receive a tow pass so you can come and go with no additional charge. If not you can purchase a pass at the gate from the individual clubs. Please ask your clients to park in day parking and not in front of your RV. It is imperative to keep our fire lanes clear at all time.

WATER is available at the end of each row. All water is just for fill and not for continuous hook up. This is a county rule and must be followed. You will need to bring extra hose with you and share with your neighbors to reach. Also bring extra electric cords with you as you are not always close to your outlets. There are no pump out facilities on the grounds. Pump outs will be available, cash only; see the driver for cost.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.



If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1. The dog show rules are posted on the AKC Web site at: http://images.akc.org/pdf/rulebooks/RREGS3.pdf Most important to note are the following:

- Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
- 2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
